上市公司發布的新季績仍優於預期，促美股六連升，但是亞洲股市卻個別發展，港股因入市資金弱，加上中移動(941)首季業績欠佳，使大市再現向下。

低見22496 急跌221點

港股昨日高開124點報22855，便見恒生指數1分鐘圖9RSI於超買區邊緣的67.786呈現大陰獨且尖頂即時強烈見頂信號，於是展開浪低於浪整固，雖先後三度試頂，卻乏力破關，回至22550至22600活動。下午跌破上午末段長方形底部，轉戰更低22525至22500，2時24分見22509，然後橫移始重返長方形，即使略破頂見22562，卻乏力再進，尾市低見22496，收盤22509.64，大跌221.04點或0.972%。全日成交額571.03億元，較上日的482.5億元增加88.53億元或18.34%，仍算量弱。

恒指日線圖由陽燭十子星待轉大陰燭穿頭破腳回落，各主要技術指標變化為：(i)9RSI底轉頂背馳跌破下降軸且中軸，短期勢頭轉弱；(ii)STC%K頂背馳跌破%D及超買區，有強烈短線派發信號，(iii)DMI+D頂背馳不斷收窄對-DI牛熊差距，中線趨扁；(iv)MACDM1頂背馳與信號線M2交繩，Diff正方回落負方，中期不穩。即日市技術解讀為：短中期技術指標反覆，仍以趨壞為主調。

美國巨企業陸續派發首季業績普見良好表現，其中Travelers Cos和United Technologies之季績優於預期，股價分別升0.6%與0.8%，而FaceBook更因季績佳急揚2.9%，成挺標普及納指升6日的動力。

標普成分股盈利增長佳

有統計資料顯示：標普500指數中有20%成分股周二派發季績，盈利增長優於估計者佔63%，營業收入優者則達51%而低於平均數之61%；至今已公布季績的公司平均利潤增長1.1%，高於最新估計的1%升幅，當然仍低於年初時所預計的6.5%，反映嚴寒天氣對美國經濟影響頗大，但基調未有太大破壞。

康健企業則受醫改政策縮細令使市場競爭加劇的消息刺激，相關股份Navartis上升1.3%和Glaxo更走高4.1%，亦成爲改善買賣氣氛的其中因由。

好消息還有：人民銀行自本周五起下調區域農村商業銀行和縣域農村會作銀行的人民幣存款準備金率，使相關涉農貸款比例較高的金融機構有更充裕信貸資源支持「三農」發展，爲配合國務院要讓金融服務「三農」發展的政策要求，相信支持與「三農」相關措施會陸續出台，以便達致強化糧食安全保障、建設現代農業、增加農民收入及縮小城鄉差距等目標。

港股失22658及22597等支持位，短線須守22416至22339區間，否則會有較大下調壓力，而22843是短線初步阻力，暫無法挑戰22912至23054。

淡友推低彈後或再跌



按年勁升2.9倍至3.17億元，由於中國鐵路改革及加大固定資產投資金額至7200億元，首季業務表現理想，預期全年銷售及交付量大幅增長，有利集團提高市佔率，估計今年海外業務佔比仍未達25%的目標，今年資本開支約5億元，不排除進行併購，評級展望穩定，預測市盈率13.8倍，估值仍算合理。

熔盛待下半年周期轉好

中國熔盛重工(1101)橫行鞏固，承接區1.27元；集團去年虧損擴至86.84億元人民幣，期內收入13.44億元降83.1%，造船板塊收入按年降84%至11.96億元，佔總收入為89%，目前已採取措施改善流動性及財務狀況，短期市場需求疲弱，或至半年行業周期才轉向。

恒指以22509收市，跌221點，焦點在資金流向，由於形態結構轉弱，淡友應借勢推低，如果失守22400，支持將下移至22000。期指以22468收市，下跌269點，低水42點，市場情緒未見太大起色，反彈後隨時回跌。
