450萬法拉利感凍內車

【香港商報訊】記者萬家成報道:沙田 馬場主看台停車場對開發生聞者「肉赤」 一輛價值逾 450 萬元名貴法拉利 跑車,昨晨駛經上址時突然失控,與一輛 凍肉貨車迎頭相撞,電光石火之間,名貴 辣跑慘遭「秒殺」,頓成一團廢鐵,兩車 共有3人受輕傷。肇事跑車司機事後聲 稱,當時是爲了閃避不明動物而扭駄才釀 成意外,更豪言將會再購另一輛法拉利

閃避不明物體扭軚肇禍

已成廢鐵的肇事法拉利跑車型號「599 F1」,全車火紅色,於 2009 年出廠及首次登 記,當年車價已逾 450 萬元,並以一間國際投 資公司名義登記。據稱,該公司其中一名負責 人爲姓楊內地女子。

資料顯示,「599 F1」跑車汽缸容量 5999cc,採用 V12 引擎,由 0 至 100 公里加速 僅需 3.7 秒,最高時速可達 328 公里,是名副 其實的超級跑車,並成爲城中名人至愛,藝人 郭富城、「快勞夾大王」杜振源及商人兼馬主 胡偉林等,均爲其捧場客。

昨晨8時38分,肇事法拉利跑車駛經沙田 馬場主看台停車場對開服務路之際,姓何男司 機(43 歲)報稱爲閃避不明動物而扭右軚,導致 跑車失控越線,迎頭猛撞向另一輛運送凍肉的 5 噸半密斗貨車,結果兩車車頭嚴重毀爛,其 中低重心的法拉利跑車,部分車頭更一度剷入 貨車底部,以致車頭嚴重扭曲變形,毀爛如廢 鐵,碎片及飛脫的零件散滿一地,至於被撞貨 車則右前車軸折斷

意外發生後,警員到場迅將現場一段路面封 閉調查,由於肇事跑車司機感到胸口痛楚,而 姓李貨車男司機(42歲)亦感到頸部及腰部痛 楚,另一名姓楊貨車男乘客(43歲)則感到頭痛
