


表明僅助投案 冀依法處理

陳婉嫻：無要求當局寬待懷仔



【香港商報訊】記者戴合聲、李淇報道：在港匿藏9年的12歲內地男童肖友懷獲發「行街紙」，引起全城熱論。協助該男童的工聯會立法會議員陳婉嫻昨日表示，沒有後悔召開記者會公開男童情況，因希望在陽光下說清楚事件，對於外界對事件及她自己的反應，會給予尊重，但對有激進團體衝擊學校「始料不及」。她透露，懷仔及家人已搬離順利邨住所，期望各界給予他們空間。有激進團體昨午更一度在網上號召要「探望」懷仔，不過一見到記者便「心虛」，各與會者都逃之夭夭，行動夭折。



陳婉嫻表示，對於有激進團體就懷仔事件衝擊學校始料不及。

陳婉嫻昨早接受電台訪問時直言，沒有後悔召開記者會公開男童肖友懷的情況，因為她期望在陽光下說清楚事情，並交給香港人作判斷；她又說，沒有要求當局需要就事件寬鬆處理，僅是協助對方投案；她說事前有考慮多種方法處理事件，也有心理準備，也預計到有人

會批評自己。

激進團體衝擊學校始料不及

陳婉嫻續說，對於外界如何對待自己，她會給予尊重，但坦言對有團體衝擊學校的情況，是始料不及，現時她希望可以給予入境處壓力，可以盡快處理事件；重申一直有協助其他人士，包括婦女、其他國家人士等；被問及如有同類案件，會否再提供協助，她重申不會評論假設問題，要視乎每宗個案而定。

籲抱大愛精神給予空間

嫻姐透露，懷仔及其家人已經搬離順利邨的住所，期望外界可以抱着大愛精神，給予他們空間。她亦說自己對於事件的立場沒有改變過，繼續認為要按法律程序處理事件，而調查若顯示沒有人照顧懷仔，特區政府也應以人道考慮提供協助。

團體玩嘢探懷仔落荒而逃

另外，有激進團體繼續就事件借題發揮。激進本土派「勇武前綫」前晚在網上號召網民到懷仔居住的順利邨示威，並聲稱要探望懷仔，警方昨午出動多名警員到順利邨巡查，大廈保安員亦貼出告示，指遇到特別情況須封閉部分

出入口。

百人遊行要求嚴正處理

活動原訂於下午2時開始，惟至近3時仍未有網民響應出現。另一個有搞事紀錄的激進組織「香港本土」的何先生其後到場，見記者即自稱純粹聲援，並打算採取任何行動，他僅於邨內逗留片刻，就急速乘的士離開，數名戴口罩的青年見狀亦落荒而逃，行動宣告夭折。至4時許，數名「勇武前綫」成員現身順利邨房屋署辦事處，他們將示威物品貼上辦事處後

就離開。

450萬法拉利撼凍肉車3傷

【香港商報訊】記者萬家成報道：沙田馬場主看台停車場對開發生聞者「肉赤」的車禍，一輛價值逾450萬元名貴法拉利跑車，昨晨駛經上址時突然失控，與一輛凍肉貨車迎頭相撞，電光石火之間，名貴辣跑慘遭「秒殺」，頓成一團廢鐵，兩車共有3人受輕傷。肇事跑車司機事後聲稱，當時是爲了閃避不明動物而扭軚才釀成意外，更豪言將會再購另一輛法拉利。

閃避不明物體扭軚肇禍

已成廢鐵的肇事法拉利跑車型號「599 F1」，全車火紅色，於2009年出廠及首次登記，當年車價已逾450萬元，並以一間國際投資公司名義登記。據稱，該公司其中一名負責人爲姓楊內地女子。

資料顯示，「599 F1」跑車汽缸容量5999cc，採用V12引擎，由0至100公里加速僅需3.7秒，最高時速可達328公里，是名副其實的超級跑車，並成爲城中名人至愛，藝人郭富城、「快勞夾大王」杜振源及商人兼馬主胡偉林等，均爲其捧場客。

昨晨8時38分，肇事法拉利跑車駛經沙田馬場主看台停車場對開服務路之際，姓何男司機(43歲)報稱爲閃避不明動物而扭右軚，導致跑車失控越線，迎頭猛撞向另一輛運送凍肉的5噸半密斗貨車，結果兩車車頭嚴重毀爛，其中低重心的法拉利跑車，部分車頭更一度剝入貨車底部，以致車頭嚴重扭曲變形，毀爛如廢鐵，碎片及飛脫的零件散滿一地，至於被撞貨車則右前車軸折斷。

意外發生後，警員到場迅將現場一段路面封閉調查，由於肇事跑車司機感到胸口痛楚，而姓李貨車男司機(42歲)亦感到頸部及腰部痛楚，另一名姓楊貨車男乘客(43歲)則感到頭痛



車主豪氣買過架新法拉利

暈眩不適，3人遂由救護車送院檢查及敷治，3人幸僅受輕傷，至於肇事跑車及貨車其後由拖車拖走處理。

2蒙面刀賊劫油站掠2200元

【香港商報訊】記者馮仁樂報道：元朗青山公路潭尾段近壘圍一間油站發生近期不多見的持刀行劫案，兩名蒙面賊人昨日凌晨手持牛肉刀闖油站打劫，將職員制服綑綁，然後劫去2200元現金逃去無蹤，職員並無受傷，事後自行報警，警員到場在附近進行兜截無果，現追緝賊人歸案。

制服女職員膠紙封口綁手

行劫案現場位於元朗青山公路潭尾段近壘圍中國石化油站，昨日凌晨2時49分，兩名身高約5呎4吋、瘦身材、戴鴨舌帽及口罩中國籍男子突然闖入油站內打劫，其中一人更持牛肉刀，指嚇一名姓胡油站女職員(56歲)，將她制服後用膠紙綑綁雙手及封口，然後掠走收銀



機內約2200元現款，得手後奪門逃去無蹤。

警料油站天眼攝下2匪容貌

女職員事後掙脫綑綁，致電報警，警方接報到場調查，並派員於附近一帶兜截，稍後在附近一個地盤檢獲懷疑賊人棄下的膠紙，由於油站裝設有閉路電視，警方相信已拍攝到賊人的容貌及行劫過程，稍後會翻查閉路電視錄影片段，以追緝在逃賊人歸案。案件交由元朗警區刑事調查隊第2隊跟進調查，暫時無人被捕。

煙盒加大警告圖像更易假冒

私煙產品中，有近四成均爲假煙，若將煙草產品的警告圖像面積擴大會增加煙草商防偽工作難度，令煙草產品更容易假冒，亦令本港私煙問題加劇。

因防偽難度增令私煙冒升

他指出，有研究顯示，現時香港消耗的香煙中每3支就有1支是私煙，而當中更有證據顯示香港私煙販賣有犯罪集團操縱，反映了私煙問題的嚴重性。


全港報販大聯盟主席廖社青指，2009年政府增加煙草稅令報販生意銳減一半，私煙亦大量流入市面，嚴重影響報販生計，而現時報販亦只能通過一些明顯的防偽特徵以及供應商去辨認煙草產品的真假，擔心新措施會令私煙假煙更爲氾濫。

他直言，作爲前線銷售人員，見證煙民消費行爲，認爲政府的措施無助減低煙民數量，甚至令貴價煙造成品牌效應，令更多年輕人購買，建議政府應該著重教育以及宣傳工作。
